# MINUTES FOR THE REGULARLY SCHEDULED VILLAGE COUNCIL MEETING: WEDNESDAY, FEBRUARY 15, 2023 AT 6:00 P.M. IN THE LIBRARY CONFERENCE ROOM

1. Call to Order

The meeting was called to order at 6:00 p.m. Present at the meeting were Mayor Sweet, Trustees Wilson and Alton. Also present was Clerk/Treasurer Christina Holder.

- Pledge of Allegiance
   Mayor Sweet led the Pledge of Allegiance.
- Approval of Agenda
   Trustee Sanchez moved to approve the agenda as amended, Trustee Wilson seconded, and the agenda was approved without opposition.
- Approval of Minutes from 01/18/2022 Meeting
   Trustee Wilson moved to approve the minutes as written, Trustee Sanchez seconded and the minutes were approved as written.
- Resolution 2023-001 Approval for SAP for 22-G2406 Jemez Springs Waste Water Plant Improvements
   Ms. Holder explained that NMED needed Council approval for the grant before it could be signed and sent back to them. Trustee Sanchez moved to approve the grant and Trustee Wilson seconded, the grant was approved unanimously.
- 6. Approval of MOUs for fiscal agents for appropriations 22-G2988 Jemez Springs Administrative Offices and 22-G2989 Public Safety Equipment Ms. Holder stated that for grants 22-G2988 and 22-G2989 would need a fiscal agent. The Mid Region council of Governments has sent a MOU for each grant for the purposes of becoming the Village's fiscal agent for both grants. Trustee Wilson moved to approve both MOUs. Trustee Sanchez seconded the motion and both MOUs were approved without opposition.
- 7. Resolution 2023-002 for Sandoval County to Manage Local Elections

Ms. Holder explained that Sandoval County sent additional emails about combining the Municipal election with other elections and that a proposed resolution was sent. Trustee Sanchez asked that the item be tabled until Mayor Pro-Tem could also be present. Trustee Wilson seconded and the item was tabled.
