# DRAFT MINUTES FOR THE REGULARLY SCHEDULED VILLAGE COUNCIL MEETING: WEDNESDAY, JULY 19, 2023 AT 6:00 P.M. IN THE VILLAGE PLAZA

### 1. Call to Order

The meeting was called to order at 6:01 p.m. Present at the meeting were Mayor Sweet, Mayor Pro-Tem Ryan, Trustees Sanchez, Wilson and Alton. Also present were Representative Christine Chandler, Bobby Dilley, Janet Phillips, Carlos Alvarado, Chief Lee Taylor, Cindy Lewis, J. Frelund, Wyatt Taylor, other multiple members of the La Cueva Fire Department, Fred Simmank, Talia Michelle, Rose Fenton and Clerk/Treasurer Christina Holder.

- 2. Pledge of Allegiance Mayor Sweet led the Pledge of Allegiance.
- 3. Approval of Agenda Mayor Sweet requested that items 11 and 12 be reversed and that public comment be added prior to the Executive Session. Mayor Pro-Tem Ryan motioned to approve the agenda with suggested changes, Trustee Wilson seconded and the agenda was approved.
- 4. Approval of Minutes from 06/21/2023 and 06/29/2023 Trustee Wilson mentioned a typo on the June 21st minutes in item 5. The word is how and should be has. He would also like a sentence added to line 8 reading "When Trustee Wilson asked there was no answer from Rose or Christina on how dollars of revenue was produced." On the June 29th minutes he wants item 5 to be changed from votes to council comments since there was no motion to vote. Trustee Wilson moved to approve both minutes with changes, Mayor Pro-Tem seconded and the amended minutes were approved unanimously.
- 5. Guest Representative Christine Chandler Representative Chandler handed out to the Council and public a 2023 Legislative Session Highlight and discussed several items that were proposed and mentioned some had passed and others did not. She also mention the webcast which is on the Legislative website that is viewable by all the public.
- 6. Discussion and Selection of Priorities for Infrastructure Capital Improvement Plan, Resolution 2023-005
  - Ms. Holder explained she sent an email to all department heads and the Council informing them of the upcoming deadline for submissions. Ms. Fenton and Ms. Phillips went over their requests and the Council will make decisions at the August 16th meeting.

- 8. Trustee Wilson mentioned a Budget Adjustment Request would be required for the Final Budget. He explained that each fund item when greater than expected needs to be adjusted to reduce the amount to \$0. It was suggested that Ms. Holder and Ms. Heather Gutierrez speak with Jim Cox who has been helping with consulting to determine which Budget items need to be adjusted and once adjusted the Budget could be approved. The Council will meet on July 24<sup>th</sup> to reevaluate the budget.
- Resolution 2023-007 Approving the Final Budget for FY 2024
   Since the 4<sup>th</sup> Quarter budget was tabled until July 24<sup>th</sup> the council will review the Final Budget at that time as well.

Chief Lee Taylor, La Cueva Fire Department mentioned that the La Cueva Fire Department was put in a bad light due to the fireworks. If asked by the Jemez Springs Chief they would have helped since they enjoy the fireworks as well and have assisted Jemez Springs many times for fireworks to happen. It has put a sour taste in their mouths that La Cueva assists Jemez Springs and then are bad mouthed at Jemez Springs meetings. If that is how La Cueva is going to be treated then Jemez Springs needs to stop relying on La Cueva.

Mayor Pro-Tem Ryan mentioned that Jemez Springs and La Cueva work well together and it might be time for La Cueva to stop responding the Jemez Springs non-emergency codes.

Cindy Lewis mentioned that La Cueva has offered many times for Jemez Springs to train with La Cueva and Jemez Springs has never shown up to any of those trainings.

Wyatt Taylor said that their volunteers are people with normal jobs as well and that if La Cueva and Jemez Springs trained together it would be better for both departments.

- J. Frelund mentioned that he is often the second volunteer on scene after Chief Taylor after a 25 minute drive to calls in Jemez Springs.
